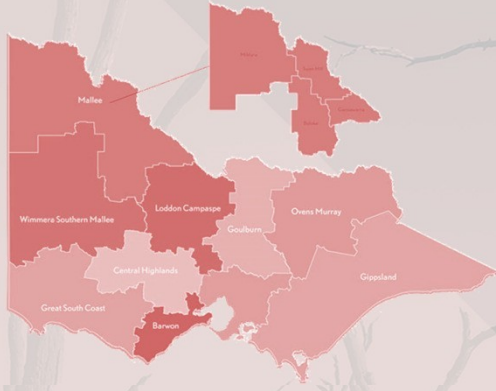


REGIONAL PARTNERSHIPS MALLEE



Bordered by the Murray River in the north and South Australia in the west, our region includes the outback region of far north-west Victoria.

The Mallee is a culturally diverse area, with a strong indigenous heritage and large Aboriginal population, as well as a growing number of new migrants and humanitarian visa holders.

The Murray River, which runs along the northern border of the region, provides access to a substantial irrigation water supply. It also lures tourists and people seeking a lifestyle change.

Irrigated agriculture and broadacre cropping drive the Mallee's economy, with the areas surrounding Mildura, Robinvale and Swan Hill providing Victoria's most productive horticultural land.

Our region includes:

- Four municipalities - Buloke Shire, Gannawarra Shire, Mildura Rural City, Swan Hill Rural City
- A Gross Regional Product of \$6 billion.
- A population of 93,000.
- 15.6% of jobs in the agricultural, forestry and fishing industry

We proudly acknowledge the Traditional Owners of the land and pay respects to their Elders past, present and future, for they hold the memories, the tradition and the culture of all Aboriginal and Torres Strait Islander people.

The provision of services in small rural towns is expensive and at times cost prohibitive. Social connectivity is constrained by geographic distance and socio-economic factors.</p>	<p>Working with health and welfare services to provide a place-based approach where targeted support to specific circumstances can be implemented. Exploring new ways to deliver health and welfare services where service provision is challenging. Building stronger partnerships and increased attention on prevention of health problems. The region's iconic food industry can also play an important role in agritourism and artisanal experiences.</p>	<p>Support the diversification of the region's economic streams by strengthening our tourism offerings. Advocate for investment in unique natural and cultural tourism assets that encourage longer term visitation.
